1. Eligibility

- 1.1. Giveaway is open only to legal residents of Minnesota (MN), Wisconsin (WI), Iowa (IA), South Dakota (SD), North Dakota (ND), and Michigan (MI).
- 1.2. Participants must be 18 years of age or older at the time of entry.
- 1.3. Participants must be under 220lbs while clothed and with shoes on.
- 1.4. Employees, owners, contractors, and immediate family members of Skydive Northstar are not eligible.
- 1.5. Void where prohibited by law.

2. Entry & Selection

- 2.1. No purchase necessary to enter or win.
- 2.2. All entries must be submitted through SkydiveGiveaway.com.
- 2.3. One winner will be selected at random on or about the date announced.
- 2.4. Winner will be notified by email, phone, or other provided contact information. If the winner does not respond within 3 days, the prize may be forfeited and an alternate winner selected.

3. Prize Details

- 3.1. Prize consists of **one (1) tandem skydive with video** at Skydive Northstar located in Waseca, MN.
- 3.2. Prize has no cash value, may not be redeemed for cash, and may not be transferred, sold, or substituted.
- 3.3. Winner is responsible for all travel, lodging, meals, and incidental costs associated with redeeming the prize.
- 3.4. Standard weight limits, health requirements, weather restrictions, and operational rules apply.

4. Scheduling & Rescheduling

- 4.1. All skydives are subject to weather conditions, aircraft availability, instructor availability, and operational limitations.
- 4.2. If a jump must be rescheduled for *any* reason—weather, safety, mechanical, or otherwise—the dropzone is not responsible for any travel expenses, lost wages, or other costs incurred by the winner.
- 4.3. The dropzone reserves the right to refuse service if the winner does not meet

safety, medical, or weight requirements. In such case, the prize is forfeited with no compensation.

5. Assumption of Risk & Liability Release

- 5.1. Winner must sign the dropzone's standard waiver, liability release, and assumption-of-risk agreement prior to jumping.
- 5.2. Failure or refusal to sign required documents results in immediate forfeiture of the prize.
- 5.3. Skydiving is an inherently dangerous activity. The winner acknowledges and agrees that the dropzone, aircraft operators, instructors, owners, and affiliates are not liable for injuries, losses, or damages arising from participation.

6. Taxes

6.1. Winner is solely responsible for any taxes, fees, or reporting obligations related to the prize.

7. Publicity

- 7.1. By accepting the prize, winner grants the dropzone permission to use their name, likeness, photos, videos, and statements for marketing, promotional, and social media purposes without additional compensation, unless prohibited by law.
